

## Covid-19 Risk Assessment



### Summary Statement

All activities will be carried out in line with current government Covid-19 guidelines and are continually reviewed. <b><u>Visitor Parking</u></b>	Low	Provide unrestricted parking to staff and visitors in the stadium footprint which offers adequate space for all vehicles to be parked at safe distance apart.	If visitor numbers increase, consider parking signage.
<b><u>Visitor queues outside arranged meeting points</u></b>	Low	Visitor numbers are restricted with allocated time slots for arrival.	If visitor numbers increase, consider parking signage or social distancing markings at designated meeting points.
<b><u>Ticket handling</u></b>	Medium	All visitors will be required to show proof of booking as condition of entry, however, there will be no handling of paper tickets by members of staff.	
<b><u>Track and Trace</u></b>	High	Player sheet to be sent to opponents with confirmation of game. Paper sheet for spectators on entrance gate. Use of EvePass App for non-contact entry.	EvePass signs with QR code to be put up at several locations near entry

<b><u>Contact with stadium external doors/gates/handles</u></b>	Medium	One single gate will be used and one member of staff only will operate this gate. Visitors/public will not touch any gates or handles. Gate handles to be sanitised before and after each event	Consider signage on the entry gate
<b><u>Walk ways and concourse safety</u></b>	Low	All visitors will be escorted to their designated open space zone in the stadium by a staff member, ensuring social distancing is observed. Walkways and concourse will be cleared of obstructions and visitors will be instructed not to touch any surfaces, fences, barriers or equipment	
<b><u>Seating Zone</u></b>	Low	Strict social distancing measures will be implemented – visitors will be directed to specific safe zones and required to stay in their allocated seats. Any breach of this direction will result in visitors being removed from the stadium. Only large stand to be used for visitor seating. Small stand and path around pitch to be cordoned off.	Stage 1 game 25 August 15% of capacity Stage 2 game 1 September 30% of capacity. Signs and tape on seats not to be used. Signs advising 2m rule.
<b><u>Seat Cleaning</u></b>	Low	Fixed plastic seats in the stadium will be used and restricted visitor numbers will ensure that seats are not used more than once in every 4 weeks. Seats used will be identified and sterilised following use in both stands.	
<b><u>Toilets</u></b>	High	Toilets will be cleaned and disinfected at regular intervals.	1 person use at a time
<b><u>Indoor Area</u></b>	Medium	Indoor areas have separate rules. See MK Irish Centre risk assessment for clarification.	
<b><u>Playing Area</u></b>	Medium	All permanent fixtures to be disinfected at the start and end of each half of game - dugouts, goalposts, corner flags, pitch barrier. All footballs to be disinfected regularly during game.	Extra seating to be provided to enable social distancing at dugouts, small stand to be used for substitutes.
<b><u>Contact with other staff or contractors working on the premises</u></b>	Low	All staff and contractors visiting the premises will be following social distancing measures and the 'Open Spaces' zones will be carefully selected to avoid the risk of any close contact.	If visitor numbers increase, continue to monitor.
<b><u>Personal property and litter</u></b>	Medium	All visitors will be instructed to keep personal property with them at all times and to remove any litter when leaving the stadium.	Litter collection or bins provided using PPE

<u>Leaving the premises</u>	Low	Staff will regulate the 'Open Spaces' zones and visitors will be escorted to the exit points by a member of staff.
